The National Law University Meghalaya is seeking to engage Research Consultant (part-time) to work on a project on Multi-scalar Dimensions of Sectoral Water Conflicts Through the Lens of Water Security.

The Research Consultant would be expected to work on specific case studies, as well as assist with background research, data collection, data management, and organization of events, as appropriate.

Title of the Project: Multi-scalar Dimensions of Sectoral Water Conflicts Through the Lens of Water Security

Name of the Post: Research Consultant

Number of Post/s: One (1)

Duration: Six months (with possibility of renewal/fixed)

Fellowship: A fellowship amount of ₹ 35,000 per month will be provided. The Consultant will be expected to work a minimum of 20 hours a week.

Eligibility:

- Law graduate (LLM, PhD degree in law) with a minimum 60% mark or a CGPA of 6.5 in 10-point scale in the qualifying examination and/or equivalent.

OR

- Master's degree/PhD in any social science discipline (Anthropology/Geography/Sociology including interdisciplinary degrees like Development Studies, Cultural Studies, Public Policy, Human Rights, others) with a minimum 60% marks or a CGPA of 6.5 in 10-point scale in the qualifying examination and/or equivalent

- Work experience (policy, research etc.) in the field of natural resources/environment/water and familiarity with water law, policy and governance;

- English proficiency and proficiency in MS Office applications. Competence in Khasi/Pnar, Garo or other languages of the North-East would be welcome.



Roles and Responsibilities:

The candidate is expected to provide comprehensive support to implement the main objectives of the project through academic, research, and professional assistance. The main tasks will include:

- Work on the specific case study allocated
- Contribute to developing and building an extensive research database and literature review concerning sectoral water conflicts;
- Conduct in-depth analysis on water security and water conflict-related issues;
- Undertake fieldwork for the purposes of the case study allocated;
- Organise project-related events, as appropriate;
- Collate, analyse and publish findings of the research;
- Undertake administrative or any other work that may be necessary with regard to the research project.
- Contribute to the filing, documentation, and other process-related aspects of the project and in its relation with the institution.

4. With one month's notice or equivalent to one month's fellowship, the contract can be terminated by both parties (the University and the candidate).
5. The fellow will go through a periodic assessment every month. Unsatisfactory performance of the fellow may lead to termination.
