**Engagement and Honorarium**

The engagement of Guest Faculty shall be purely temporary, contractual, and need-based, for teaching courses assigned by the University during the relevant academic term(s).

Guest Faculty shall be paid an honorarium in accordance with their qualifications and experience, as detailed below:

1. Assistant Professor Level – ₹1,500/- (Rupees One Thousand Five Hundred only) per teaching hour, subject to a maximum ceiling of ₹50,000/- (Rupees Fifty Thousand only) per month.

2. Associate Professor Level – ₹2,500/- (Rupees Two Thousand Five Hundred only) per teaching hour, subject to a maximum ceiling of ₹75,000/- (Rupees Seventy-Five Thousand only) per month.
3. Professor Level / Distinguished Expert – ₹5,000/- (Rupees Five Thousand only) per teaching hour, subject to a maximum ceiling of ₹1,00,000/- (Rupees One Lakh only) per month.

The engagement shall not confer any right to claim regular appointment, absorption, continuation, or any other service benefit under the University. No allowances, benefits, or financial entitlements of any nature shall be admissible other than the honorarium specified above.
